I would also like to inform you that I am currently conducting many activities related to Peace in the form of a Competition.

The Competition is organized in cooperation with the author, Prof. Zbigniew Roth, under the patronage of the Sovereign Artists and Writers of the World SAPS POLSKA, whose President is the author mentioned above. The Competition is planned in three stages, which allows for several variations, depending on the organizer's capabilities

## Prof. René Wadlow Suisse

### President of the Association of World Citizens

UN Geneva

The UN Human Rights Council Special Rapporteurs have painted a grim picture of the disproportionate level of suffering experienced by girls and especially pregnant women in Gaza.

“The treatment of pregnant and lactating women continues to be appalling with the direct bombardment of hospitals and the deliberate denial of access to health care facilities by Israeli snipers, combined with the lack of beds and medical resources placing an estimated 50,000 pregnant Palestinian women and 20,000 newborn babies at unimaginable risk.”

Many of these military actions are in direct violation of International Humanitarian Law as set out in the Geneva Conventions of August 12, 1949 and the Protocol Additional adopted in 1977. In order to meet new situations, International Humanitarian Law (IHL) has evolved to cover not only international armed conflicts but also internal armed conflicts. IHL prohibits the indiscriminate killing of civilians, the holding of hostages, and the destruction of medical and educational infrastructure.

The Association of World Citizens stresses the importance of IHL as a vital part of world law that will replace unilateral actions by States based on narrow domestic political considerations. The standards of IHL require political will if they are to function effectively. Thus, nongovernmental action on the Gaza Strip armed conflict is urgently needed.

From 26 to 29 September 2024, the Helier Hotel hosted a group of 42 participants from 16 different locations, belonging to 4 religious traditions - Orthodox Christians, Catholics, Muslims and Protestants.

“Sowing Peace.BG” was a continuation of the URI Europe interfaith camp held in August in The Hague where 4 CCs and European countries collaborate. It also echoes the theme of this year’s

UN Day of Peace: Cultivating a Culture of Peace. The format was fully funded by BRIDGES, through the winning of the first prize of the King Abdullah II of Jordan Prize for Interfaith Harmony, competing with 1186 events from around the world organized within the framework of the United Nations Tolerance Week (WIHW). The association “Nestos Youth Initiatives” was our partner and host in Yakoruda.

A World Citizen is any person who recognizes their membership in the world community, behaves in accordance with this identity, and calls for global problems to be the responsibility of democratic global institutions.

Whether registered or not, every person therefore has the right to call themselves a "world citizen" The institution REGISTER OF WORLD CITIZENS (RCM), founded in 1949, is made up of all those responsible for registration (Centers, Correspondents and Officers) and volunteers (associate members).

The Register of World Citizens is an institution independent of States and all powers. In order not to be subject to any particular national law, the federal level of the institution has no headquarters in any national State; it is placed under the competence of the Delegates elected to the People's Congress (extract from the preamble of the Federal Regulations)

Main functions of the Registry:

- Registration of individuals as World Citizens and issuance of World Citizen Identity Cards
- Registration of territories as "World Citizen Territories" - animation of the Council of Territories CDM
- Establishment of world electoral lists (in conjunction with the People's Congress)

The Registry of World Citizens is the only organization in the world authorized to distribute World Citizen cards directly to individuals or through "centers" that it has accredited.

As a "world civil registry service" it works to establish the world electorate.
